BIOGRAPHIES



LORENZO CASINI

Lorenzo Casini is a Full Professor of Administrative Law at IMT School for Advanced Studies in Lucca (Italy), where he teaches Global Law and Cultural Heritage Law. Since September 2019 he has been serving as Chief of Staff of the Italian Minister for Cultural Heritage and Tourism. From 2009 to 2014 he served as a law clerk to Justice Professor Sabino Cassese at the Constitutional Court of Italy. He has been Research Fellow at the New York University School of Law on several occasions. He has published extensively in public law, and comparative and global administrative law. He is the Co-President of the International Society of Public Law (ICON-S).



JORGE CONTESSE

Jorge Contesse is a scholar of international human rights and comparative constitutional law, focusing on the judicialization of international law and on the interaction between Latin American constitutional actors and international human rights regimes. His work has appeared in leading international law journals, and he has held several visiting positions. Prior to joining the Rutgers' faculty, he served as a board member for Chile's National Human Rights Institute. He holds an LL.B. from Diego Portales Law School and LL.M. and a J.S.D. degrees from Yale Law School.



CÉSAR CORONEL ORTEGA

César Coronel Ortega is Co-Chair of the Latin America Interest Group of the American Society of International Law. He is a Senior Associate at the law firm of Coronel & Pérez in Ecuador, working at the firm's offices in Guayaquil and Quito. He works mainly in international disputes, and also practices in the areas of constitutional, antitrust and corporate law in Ecuador.

He has worked at the law firms of Three Crowns LLP in London and Winston & Strawn in New York. He has also worked at the United Nations Office of Legal Affairs in New York, as a Legal Advisor at the National Constituent Assembly of Ecuador.

He has lectured on International Law at the Universidad de los Hemisferios in Quito and at the Master's Program in International Arbitration and Litigation at Universidad San Francisco de Quito. He obtained

his law degree (LL.B.) at the Catholic University of Guayaquil, and an LL.M. from New York University School of Law. In addition, he holds a B.S. in International Politics and a Certificate in Latin American Studies from Georgetown University's School of Foreign Service.



ANUSCHEH FARAHAT

Anuscheh Farahat is a Professor of Public Law, Migration Law and Human Rights Law at the University of Erlangen-Nürnberg and Senior Research Affiliate at Max Planck Institute for Comparative Public Law and International Law. Anuscheh is currently leading a research group on transnational solidarity conflicts in the EU, which is funded by the German Research Foundation (DFG). She publishes widely on issues of constitutional law, migration law, and human rights law.



DAN FARBER

Dan Farber is the Sho Sato Professor of Law and the Faculty Director of the Center for Law, Energy, and the Environment at the University of California, Berkeley. Professor Farber serves on the editorial board of Foundation Press and is a member of the American Academy of Arts and Sciences and a Life Member of the American Law Institute. After graduation from the University of Illinois law school, Professor Farber was a law clerk for Judge Philip W. Tone on the Seventh Circuit and then for Justice John Paul Stevens on the Supreme Court. Professor Farber practiced law with Sidley & Austin before returning to the University of Illinois as a faculty member in 1978. From 1981 to 2002, he taught at the University of Minnesota Law faculty, where he was the McKnight Presidential Professor of Public Law. He also has been a Visiting Professor at the Stanford Law School, Harvard Law School, and the University of Chicago Law School. He is an author of leading casebooks on constitutional law and environmental law.



FRANK J. GARCÍA

Frank J. García is Professor of Law and Dean's Distinguished Scholar at the Boston College Law School. A Fulbright Scholar, he has lectured widely on globalization and international economic law in Europe, South America and the Asia/Pacific region. He is the author of, among other volumes, *Consent and Trade: Trading Freely in a Global Market* (2019) and *Global Justice and International Economic Law: Three Takes*, both published by Cambridge University Press, and a co-author (with Aisbett, et al.) of *Rethinking International Investment Governance: Principles for the 21st Century* (2018). Professor García is a Senior Fellow of the Columbia Center on Sustainable Investment, and a member of the editorial board of the *Oxford Journal of International Economic Law*.



JAMES T. GATHII

James T. Gathii is the Wing-Tat Lee Chair in International Law and Professor of Law at Loyola University Chicago School of Law since July 2012. He is a graduate of the University of Nairobi, Kenya, and Harvard Law School. He sits on the board of editors of the *American Journal of International Law*, the *Journal of African Law* and the *Journal of International Trade Law and Policy*, among others. He is co-editor in Chief of the *African Journal of International Economic Law*. He was the Grotius Lecturer at the 2020 American Society of International Law Virtual Annual Meeting. His research and teaching interests are in Public International Law, International Trade Law, Third World Approaches to International Law, (TWAIL), Comparative Constitutional Law and Human Rights. Professor Gathii served an Independent Expert of the Working Group on Extractive Industries, Environment, and Human Rights Violations in Africa formed by the African Commission on Human and Peoples' Rights between 2012 to 2020.

He is also an expert member of the Working Group on Agricultural Land Investment Contracts of the International Institute for the Unification of Private Law, (UNIDRIT), the Food and Agricultural Organization (FAO) and the International Fund for Agriculture (IFAD). He has sat as an arbitrator in two international commercial arbitrations hosted by the Permanent Court of Arbitration in the Hague. He is a founding member of the TWAIL network. He is an elected member of the International Academy of International Law. He has consulted for the Office of the United Nations High Commissioner for Human Rights, (OHCHR), and the Economic Commission for Africa, (ECA), among others. Professor Gathii is a founding Editor of *Afronomicslaw.org*, the blog on international economic law issues relating to Africa and Global South. His books include *African Regional Trade Agreements as Legal Regimes* (Cambridge University Press, 2011, Paperback 2013); *War, Commerce and International Law* (Oxford University Press, 2010); and *The Contested Empowerment of Kenya's Judiciary, 2010-2015: A Historical Institutional Analysis*, (Sheria Publishing House, 2016). His latest edited book is *The Performance of Africa's International Courts: Using Litigation for Political, Legal, and Social Change*, (Oxford University Press in 2020). In addition to his books, Professor Gathii has authored over 90 articles and book chapters.



TOM GINSBURG

Tom Ginsburg is the Leo Spitz Professor of International Law at the University of Chicago, where he also holds an appointment in the Political Science Department. He holds B.A., J.D. and Ph.D. degrees from the University of California at Berkeley. He currently co-directs the Comparative Constitutions Project, an NSF-funded data set cataloging the world's constitutions since 1789, that runs the award-winning Constitute website. His latest book is *How to Save a Constitutional Democracy* (2018, with Aziz Huq), and his other books include *Judicial Reputation: A Comparative Theory* (2015) (with Nuno Garoupa); *The Endurance of National Constitutions* (2009) (with Zachary Elkins and James Melton), which won the best book award from Comparative Democratization Section of American Political Science Association; and *Judicial Review in New Democracies* (2003), winner of the C. Herman Pritchett Award. He is a member of the American Academy of Arts and Sciences. Before entering law teaching, he served as a legal advisor at the Iran-U.S. Claims Tribunal, The Hague, Netherlands, and he has consulted with numerous international development agencies and governments on legal and constitutional reform. He currently serves a senior advisor on Constitution Building to International IDEA.



GABRIELLE MARCEAU

Gabrielle Marceau, Ph.D., is Senior Counsellor in the Research Division (ERSD) of the WTO Secretariat since 1 May 2020. In September 1994 Mrs Marceau joined the GATT Secretariat and for several years her main function was to advise panellists in WTO disputes, the Director-General's Office, the Secretariat and WTO Members on WTO-related matters. From September 2005 to January 2010, Mrs Marceau was legal advisor in the Cabinet of former WTO Director-General Pascal Lamy, and from September 2016 to January 2017, she was acting director, Officer in Charge for Legal Affairs Division.

Gabrielle Marceau is also Associate Professor at the Law Faculty of the University of Geneva; she has been Visiting Professor at the Graduate Institute in Geneva, the Sorbonne in Paris, Monash University in Melbourne, the World Trade Institute in Bern, and many other institutions. Professor Marceau is also involved with associations and groups promoting international (economic) law. Professor Marceau has

published extensively in WTO law and international economic law.

Before joining the GATT Secretariat, Gabrielle Marceau, member of the Quebec/Canada Bar, worked in private practice in Quebec, Canada, mainly in labour, insurance law and civil law.



SABRINA RAGONE

Sabrina Ragone is a professor of comparative law at the University of Bologna and a senior research affiliate of the Max Planck Institute for Comparative Public Law and International Law, Heidelberg (MPIL). Previously, she was a research fellow at the Centre for Political and Constitutional Studies (Madrid) and the Autonomous University of Barcelona. She has held research and visiting professor positions in several academic institutions in Europe, as well as in Latin America and the US. Her extensive publications address comparative law methodology and substance in Italian, English, Spanish, German, Portuguese and French. She has authored five books, five edited books and more than ninety journal articles and book chapters. Her latest book: *"Parlamentarismos y crisis económica: afectación de los encajes constitucionales en Italia y España"* [Parliamentary Systems and Economic Crisis: Changes to Constitutional Arrangements in Italy and Spain], Bosch, 2020.



PABLO SAAVEDRA

Pablo Saavedra has been the Executive Secretary of the Inter-American Court of Human Rights in San José, Costa Rica, since 2004. He was previously Deputy Secretary of the Inter-American Court (2001–2003). He received his undergraduate degree from Diego Portales University in Chile and earned his master's degree in International Law at the University of Notre Dame. He was a lawyer of the National Corporation for the Reparation and Reconciliation of Chile, where he investigated human rights violations that occurred between 1973 and 1989. He has also worked as a lawyer in the Inter-American Commission on Human Rights between 1997 and 2001. He has published extensively on human rights and has been a speaker at conference in Europe and the Americas.



ALBERTO ABAD SUÁREZ ÁVILA

Alberto Abad Suárez Ávila lives in Mexico City where he is a full-time professor and coordinator of the Sociology of Law department at the Instituto de Investigaciones Jurídicas Universidad Nacional Autónoma de México (IIJ-UNAM). He is also a CONACYT National Researcher Level II and Affiliate Scholar to the Center for US and Mexican Law at the University of Houston Law Center. He belongs to the Law and Society Association, the International Society of Public Law and the Latin American Studies Association. Alberto has published about Human Rights and the judicial system in Mexico.



AMAYA ÚBEDA DE TORRES

Amaya Úbeda de Torres is a senior lawyer at the European Committee of Social Rights, at the Council of Europe. She holds a Ph.D. by both the Universities of Strasbourg and Complutense of Madrid. Her Ph. D. obtained the René Cassin prize to the best thesis on Human Rights. She teaches International Law and Human Rights at the IE University and been a visiting scholar at, among others, the Columbia University, the London School of Economics and La Sorbonne and has published over 30 academic publications in the field of International Law, the European and the Inter-American Human Rights systems and the dialogue of judges.



ELIZABETH TRUJILLO

Elizabeth Trujillo is the Mary Ann & Lawrence E. Faust Professor of Law and the Founding Director of the Initiative on Global Law and Policy for the Americas. She writes and teaches in international trade and investment law, USMCA, sustainable development and energy, contracts, and international law. Her publications which can be found in leading law reviews, books, and peer journals, examine the legal and policy overlaps between international trade and investment and domestic regulatory processes, specifically in the areas of energy, the environment, and sustainable development. Her more recent work focuses on the trade considerations for domestic decarbonization strategies in the context of changing international economic legal frameworks, with an emphasis on the Americas. Professor Trujillo has been the recipient of the Alexander von Humboldt Foundation Research

Fellowship and is writing a book on *Shattered Prisms: Reconceptualizing Trade through a Sustainable Development Framework*, which will be published with Cambridge University Press. In 2017, Professor Trujillo was elected to the American Law Institute and she serves on the Executive Council of the American Society of International Law.



RENÉ URUEÑA

René Urueña is an Associate Professor and Director of Research at the Universidad de Los Andes School of Law (Colombia). He holds a doctoral degree (exima cum laude) from the University of Helsinki, has been several times an expert witness before the Inter-American Court of Human Rights, and served as an adviser of the Selection Committee of the Special Jurisdiction for Peace (Colombia).



PEDRO VILLARREAL

Pedro Villarreal is a Senior Research Fellow at the Max Planck Institute for Comparative Public Law and International Law. He is manager of the project “International Health Governance”. In 2017, he received the prize for the best doctoral dissertation in law and social sciences at the National Autonomous University of Mexico for his work, “Pandemics and Law: A Global Governance Perspective”.
