Learning Outcomes: I have three goals for this course. First, the course will teach you fundamental federal civil procedure, its rules and doctrines. Second, the course will help with understanding of the overall litigation system in the United States; Third, the course will assist you in bar preparation and developing your basic lawyering skills. This includes the ability to spot the issue, state a rule, and draw conclusions and examine its application in other cases and contexts.

Course Attendance and Participation: Consistent with university policy, 80 percent attendance in class is required. An attendance list will be circulated at each class session. Those individuals not satisfying the attendance requirement will be reported to UH Law Center administrative officials to be dropped from the course. During class, students will be called on at random (Socratic method) to answer questions about the reading. Students will be expected to have read the assigned readings prior to class and to be prepared to discuss the material in class.

Grade and Assessment Methods: Your final grade will be based on a final examination given at the end of the semester, consisting of a potential combination of multiple choice, essay, and/or short answer questions. It will be CLOSED BOOK to better assist you in preparing for the bar exam.

Use of your laptop for any other purpose is prohibited during class meetings (e.g., you may NOT surf the internet, play games or give/receive answers or other aid via any method).
