I. Required Course Materials

The <u>required</u> book for this course is <u>ENERGY</u>, <u>ECONOMICS AND THE</u> <u>ENVIRONMENT</u> (6th Edition), by Joel Eisen, Emily Hammond, Jim Rossi, David Spence and Hannah Wiseman (West Academic Publishing 2024). Course reading assignments will be primarily based on this text.

An <u>optional</u> book for this course is <u>ENVIRONMENTAL LAW AND POLICY</u> (5th Edition), by James Salzman & Barton H. Thompson (West Academic Publishing 2019). This book may be used as a primer for understanding the environmental law concepts and issues, esp. for those students who have not taken any similar courses.

III. Teaching Objectives and Learning Outcome

By the end of the course, you will be able to:

- Understand the unifying characteristics of energy law as well as the connections to environmental issues affecting energy industries;
- Understand and identify overarching energy and environmental law principles, theories, and policies;
- Understand, identify, and articulate policy arguments commonly used in energy and environmental law;
- Articulate and express a well-informed opinion regarding related issues;
- Develop skills in legal analysis, reasoning, research, problem-solving, and written and oral communication related to energy and environmental law; and
- Draft an independent research paper regarding a topic or issue that *addresses* both energy law <u>and</u> environmental law, and do a presentation on the paper.

IV. Syllabus Changes

This document is a syllabus, not a contract. Therefore, it is subject to change. Any changes will be announced by me in class, posted on Canvas, or distributed via email to the entire class.

V. Reading Assignments

The reading assignments for the semester are listed on the Reading Assignments document attached hereto and posted on Canvas. Students are to prepare for each class by reading the entire assignment for the day before attending class. I plan for us to cover one assignment per class period. However, there will be days when it may take us more or less than one class period to cover an assignment. You are responsible for keeping track of what assignment number we are on throughout the semester. I will do my best to tell the class if I think we will not reach or complete the next day's assignment. If you miss a class meeting, it is your responsibility to check with a classmate to determine whether the class finished the entire assignment on the day you missed.

VI. Class Preparation and Participation

I call on students randomly, although I typically announce a two- or three-student panel at the beginning of each class. If I call on you and you are unprepared, you will be marked absent for that day. If you are unprepared on the date you are assigned to present on the panel, your final grade for the course may be reduced by 1/3 (e.g., an Abecomes a B+).

VII. Final Paper in Lieu of Final Examination

There will be no final exams in this class. In lieu of a final exam, each student is required to submit a Final Paper that covers any energy and environmental research topic of the student's choice that is pre-approved by the professor and related to the course. The Final Paper must be typewritten, 25 pages minimum (excluding citations), double-spaced, and properly cited using appropriate *Bluebook* format. A complete hard copy draft of the Final Paper must also be timely submitted for review in advance by April 7, 2026. The revised Final Paper (in lieu of a final exam) must be turned via the EBB Portal on or before May 5, 2026, by no later than 4:00 p.m. (CT) in order to be considered timely.

• NO LATE PAPERS WILL BE ACCEPTED AFTER THE DEADLINE. ONCE THE FINAL PAPER HAS BEEN SUBMITTED VIA THE EBB PORTAL, IT MAY NOT BE RETRIEVED OR RESUBMITTED.
